Applications from intending eligible candidates are hereby invited for filling up the vacant post of Head Assistant in the Establishment of the Chief Judicial Magistrate Establishment, Hailakandi in the usual scale of pay band of Rs. 22,000/- - Rs. 97,000/- plus Grade Pay of Rs. 10,300/- (PB-3) per month plus other allowances admissible as per Rules.


The intending candidates, those who have served as Upper Division Assistants with at least 10 (ten) years of service as such to their credit including Supervisory Assistants in any Chief Judicial Magistrates Establishment (Ministerial), within the State of Assam, may apply. However, the Selection Board reserves the right to relax the requisite criteria in case of need and exigencies in terms of Rule 17 of Assam Chief Judicial Magistrate Establishment (Ministerial) Service Rules, 1987. The Candidates shall have to appear before the Selection Board for interview on their own expenses as and when called for and No TA/DA will be paid for appearing in the interview.

The intending candidate shall submit their application in Standard Form as published in the Assam Gazette in Part IX, addressed to the Chief Judicial Magistrate, Hailakandi, with 3 (three) copies of self attested recent colour passport size photographs (one pasted and other to be stapled), experience certificate cum NOC issued by the competent authority/respected Chief Judicial Magistrate through proper channel along with other testimonials including copy of Service Book and copies of ACR of last 3 (three) years.

The eligibility and criteria for selection shall be on the basis of provision of Rule 6(1) of the Assam Chief Judicial Magistrate Establishment (Ministerial) Service Rules, 1987 R/W Rule 17 of Assam Chief Judicial Magistrate Establishment (Ministerial) Service Rules, 1987.
